- Restriction if storage: it shall not be stored together with any other class of petroleum.
- Except under and in accordance with the license granted under these rules.

- M.A.-I license to acquire, store and use Methanol.
- M.A.-II license for Sales of Methanol.
- Addition and alteration in the above license.
- Renewal of License.
- Poison license from the concerned district magistrate.
- Explosive license from the explosive department.

Ethanol

- Approval of production program (app) from Gandhinagar prohibition and excise license.
- From concerned district Supt. of Prohibition and Excise.
- Quota from the Commissioner of Prohibition and Excise Gandhinagar addition and alteration in quota from above dept.
- Renewal of license.

Poison License

- Poison License from the concerned District Magistrate / Concern office.
- Explosive license for items covered in poison license if Applicable.
- Renewal of poison license.
- Amendment, addition and alteration in poison license.
